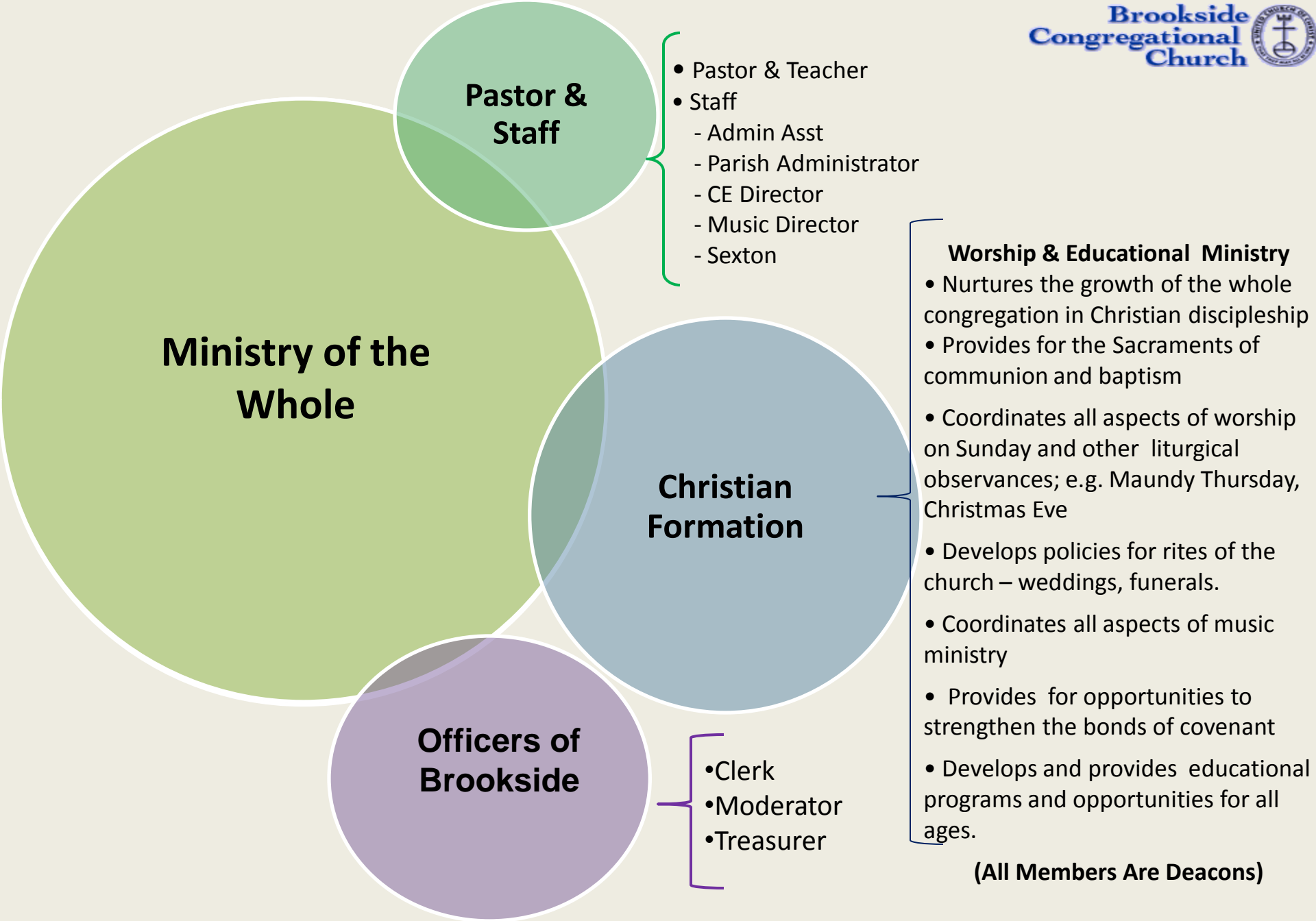

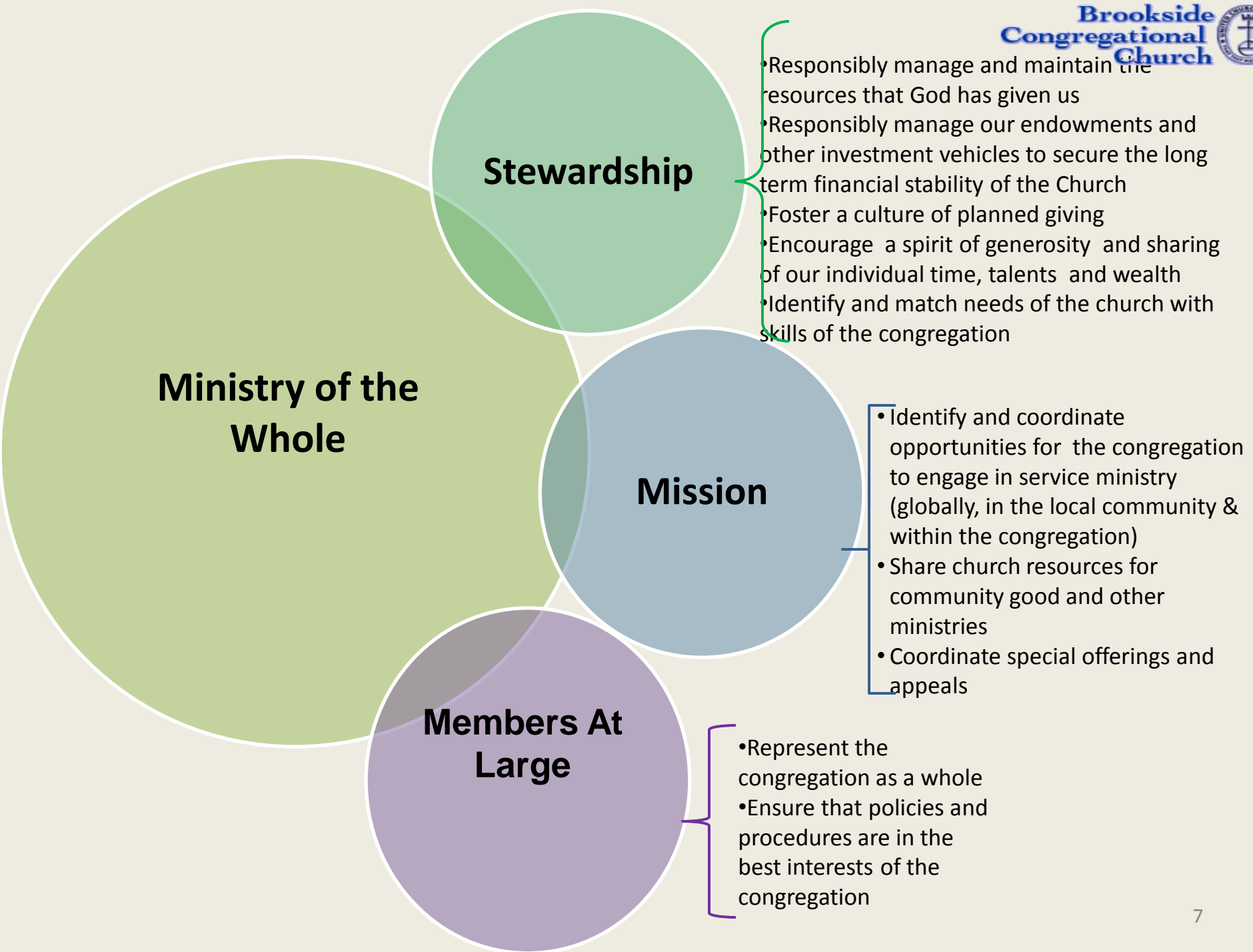


Mapping of Proposed Ministries from Current Structure

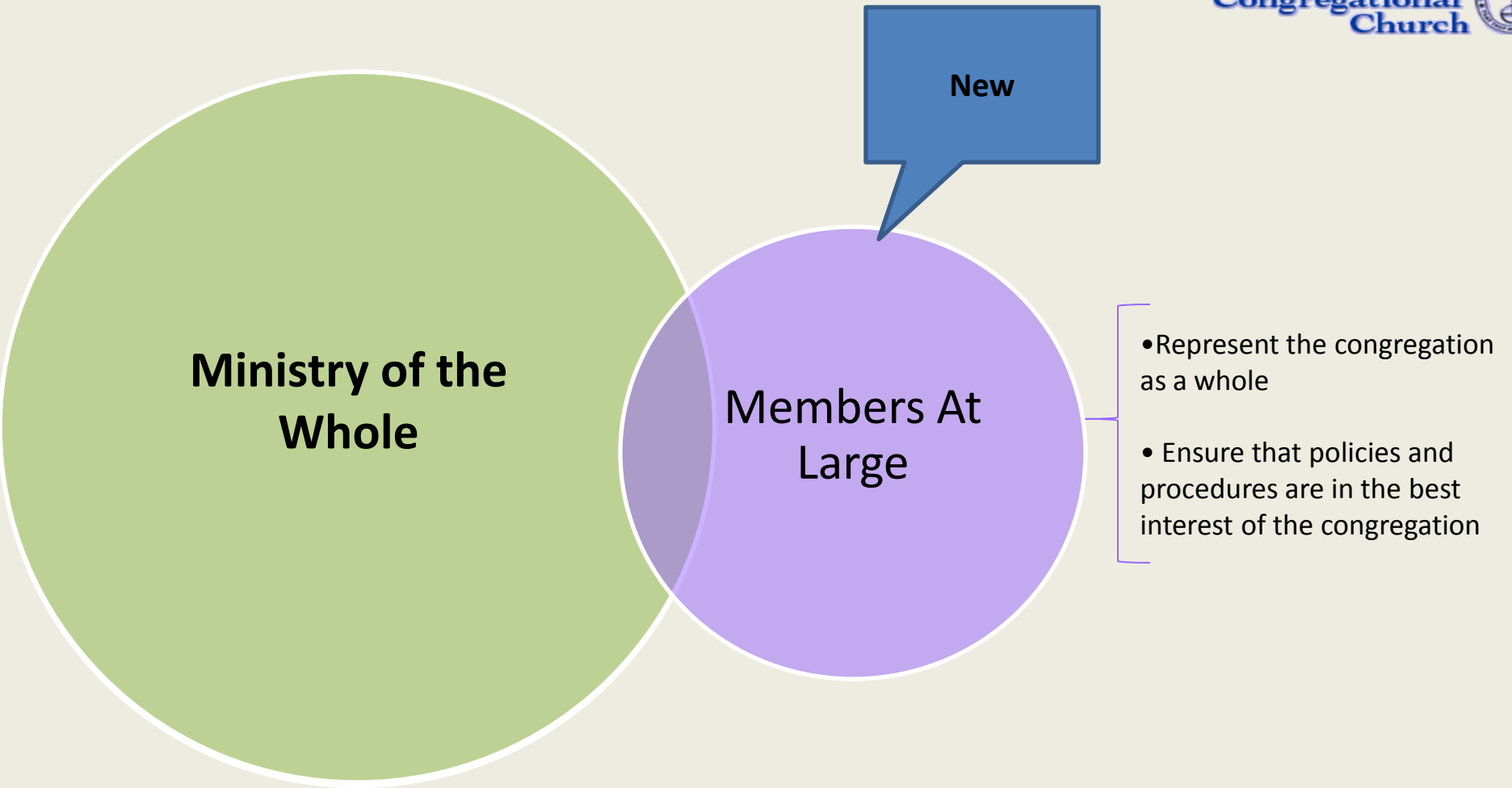
